- 4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same on violation of terms and conditions laid down in Govt. Acts / Rules / Executive Instructions.
- 5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
- 6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
