



1. Running/Starting of Class IX, X & XI, XII without prior Provisional Affiliation upto secondary level/Sr. Secondary level from the Board would be unauthorised classes and school shall be responsible for the consequences arising out of it.
2. School will not prepare any student/start any class for any other Board except CBSE from their CBSE affiliated school building/premises.
3. The Board would not allow any transfer of property/sale of school by one society/Management/Trust to another society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly, the Board shall withdraw its affiliation with immediate effect.
4. Pay & Allowances to staff should be revised time to time to bring it at par with that to State Govt.
5. The service conditions be strictly followed as per State Education Act and staff be given appointment/confirmation letters etc. accordingly.
6. 5-6 names of persons not below the rank of Principal of Sr. Secondary school affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the school Managing Committee.
7. The school shall maintain section teacher ratio at least 1:1.5 at each level i.e. Primary (I-V) Secondary (VI-X) and Sr. Secondary (XI-XII)

6. The school will strictly adhere with all rules regarding safety of students including Fire-fighting, Drinking water, Sanitation, Transportation, etc.
7. Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.
8. Other conditions are enclosed as per Annexure 'A'.
9. **Special conditions to be complied within three months:-**

- a. The school is required to appoint sufficient no. of qualified and trained teachers to maintain section teacher ratio 1:1.5 for each level
- b. The school is required to ensure that pay-scales, DA and other admissible allowances are being paid at par with the corresponding categories of employees working in the State Govt. Schools as per Affiliation Bye-laws of the Board and disburse the salary through Bank & also submit photocopy of acquittance roll after complying with the above condition.
- c. The school is required to ensure that no staff member may be appointed / continued in the services of the school who has attained the age of superannuation.
- d. The School Managing Committee is required to be reconstituted having each of 02 parents representative, teacher representatives and 02 Principals of affiliated schools preferably of Kendriya Vidyalaya / Jawahar Navodaya Vidyalaya.
- e. The school is required to establish Composite Science lab for Secondary classes.
- f. The school has 30 classrooms against Zero section. Therefore, clarification in this regard is required to submit to this office.
- g. The school is required to submit class/section wise enrollment as per norms of the Board.
- h. As per details of enrollment of students of the school, optimum limit is not maintained in all classes. Hence section-wise enrollment of students may be restricted with optimum number of 40 students per section.
- i. The school is required to furnish a copy of EPF Challan.
- j. The school is required to create the reserve fund as per strength of the school in the joint names of Secretary, CBSE and Manager of the school as per provisions of Affiliation Bye-Laws of the Board and copy of FDR so created be furnished to the Board for record purpose.
